Applications are invited on the prescribed format, for filling-up three vacancies of *Clerks*, meant for "*Physically handicapped category*", on the establishment of the High Court of Himachal Pradesh, in the Pay Band of ₹5910-20200 + ₹1900/- Grade Pay, with initial pay of ₹7810/- plus usual allowances, from amongst the graduate candidates, having knowledge of English typing at the speed of 30 words per minute. The candidate should not be less than 18 years and more than 45 years of age as on **4.11.2011**. Candidates already in service should apply through proper channel.

Applications complete in all respects, may be sent to the Registrar General so as to reach on or before **4.11.2011**. Incomplete applications or the applications received after the aforesaid date, shall not be entertained.

1. Applications received after due date or incomplete applications or not with attested copies of certificates, or not in accordance with the prescribed format shall be out rightly rejected and no correspondence will be entertained in that respect. The words "*Applications for the post of Clerk*" should be superscribed on top of the envelope containing the application form.
2. "**Physically handicapped category**" means and includes the following:
 - (a) The candidates suffering from hearing impairment, provided that such impairment is not of 60 decibel or more, after hearing aid/surgical correction.
 - (b) The candidates suffering from locomotor disability
Note: Person with normal upper limb can also be considered.)
Provided further that the candidate
 - (i) should not have any mental retardation of any degree and major mental illness like (Schizophrenia or affective disorder and chronic psychosis).
 - (ii) should not have any Neurological disorder having impaired higher mental function/ cognition and significant speech defect;
 - (iii) should have normal vision.
3. Out of three vacancies, 1st and 3rd vacancies will filled up from the category (a) and the 2nd vacancy from amongst the candidates belonging to category (b), mentioned hereinabove.
4. The candidature of only such candidates who are found eligible and whose applications are complete in all respects shall be considered for the posts.
5. No TA/DA shall be admissible to the candidates called for interview.
- 6.. The candidates appointed shall have to pass the typing test with a speed of 30 words per minute within the period of probation which term includes extended probation period, if any.
